Name of Position : Project Fellow

Duration : From the date of joining to 31.03.2026 or co-terminus with the above projects whichever is earlier (likely to be extended).

Essential Qualification : Three or Four years Bachelor degree in B.Sc /B. Tech in [(Agriculture biotechnology / Plant Breeding and Genetics / Biotechnology / Life Sciences / Basic Sciences/ Biotechnology/ Biochemistry/ Bioinformatics/ Botany) Botany with specialization in molecular biology and bioinformatics] from recognized university

Desirable : Working experience in sugarcane and Master Graduation in any degree in life/basic sciences.

Emoluments : Rs.20,000/- per month (Consolidated)

Age : Upper age limits are 30 years for men & 35 years for women. The age limits are relaxable for SC, ST & OBC candidates as per Govt. of India norms.

1. The written test cum interview for the above position will be conducted through in- person at ICAR –SBI, Coimbatore on 05.01.2026 at 9.00 AM.
2. The candidates should bring bio-data (in prescribed proforma) entire original certificates from SSLC onwards, one set of photocopies of certificates (self-attested), experience certificate and latest passport size photograph at the time of written test for verification. Candidates those who fail to submit original certificates for verification will not be allowed for written test.
3. The candidate should hold Degree certificate (at least Provisional certificate) in original in r/o. Graduation//Post graduation/Professional courses (website results/ Awaiting for results candidates will not be allowed/considered).
4. No objection certificate from the employer, in case he / she is employed elsewhere.
5. No TA/DA will be paid to any candidate to attend the Written test.
6. The above position is purely on temporary basis and is co-terminus with the project.

7. There is no provision of re-employment after termination of project. The selected candidates will not have any right for claiming pay scale or absorption against any regular post being vacant on a later date at this Institute.
8. **The selected candidate will be working on whole time basis and will not be allowed to register himself/herself for any academic programme etc.**
9. Concealing of facts or canvassing in any form shall lead to cancellation of candidature or termination.
10. **All eligible candidates are requested to be present 60 minutes before reporting time on the date of written test cum interview for necessary formalities and verification of documents.**
11. Selected Candidates (s) will be required to produce all original documents(certificates) at the time of Joining for verification purpose.
12. The selected candidate will be required to produce medical certificate at the time of joining.
