It is proposed to fill up one position of “YOUNG PROFESSIONAL-II” on contractual basis under the DBT project entitled “Development and validation of a high-throughput genome-wide SNP array for Sugarcane (*Saccharum spp.*)” by walk-in-written test-cum-Interview at ICAR-Sugarcane Breeding Institute, Coimbatore-7 (Tamilnadu) on **08.06.2026** at **9.00 AM**.

- Name of Position : Young Professional-II
- Duration : Two years
- Essential Qualification : Post-graduation in **Agriculture / life/basic sciences in Plant Molecular Biology / Plant Sciences / Genetics & Plant Breeding / Biotechnology / Biochemistry / Microbiology /Botany.**
- Desirable Qualification : Proficiency in conducting experimental trials and recording of biometric data knowledge on MS office..
- Emoluments : Rs.42,000/-per month(consolidated)
- Age : Minimum age will be 21 years and maximum age 45 years with relaxation as per rules

1. The **written test cum interview** for the above position will be conducted through **in-person** at ICAR –SBI, Coimbatore on **08.06.2026** at **9.00 AM**.
2. The candidates should bring bio-data (in prescribed proforma) entire original certificates from SSLC onwards, one set of photocopies of certificates(self attested), experience certificate and latest passport size photograph at the time of written test for verification. **Candidates those who fail to submit original certificates for verification will not be allowed for written test .**
3. The candidate should hold Degree certificate (atleast Provisional certificate) in **original in r/o. Graduation / Post graduation / Professional courses.**(website results/Awaiting for results candidates will not be allowed/considered).
4. No objection certificate from the employer, incase he / she is employed else where.
5. No TA/DA will be paid to any candidate to attend the Written test.
6. The above position is purely on temporary basis and is co-terminus with the project.

7. There is no provision of re-employment after termination of project. The selected candidates will not have any right for claiming pay scale or absorption against any regular post being vacant on a later date at this Institute.
8. **The selected candidate will be working on whole time basis. He /She will be allowed to register Ph.D. as per ICAR guidelines only with a recognized University by UGC/ICAR-AU system. The student and guide/PI of the scheme must follow the rules and regulations of the Institute as well as the University where the student has registered with.**
9. **To facilitate young professionals in pursuing a Ph.D programme, it has been decided that permission may be granted on a case to case basis to Young professionals recruited under a specified externally funded scheme, provided that the Principal Investigator of the scheme is also the Ph.D Chairperson of the candidate. However, such candidates shall not be permitted to continue the Ph.D programme under any Young Professional position other than the approved scheme.**
10. Concealing of facts or canvassing in any form shall lead to cancellation of candidature or termination.
11. **All eligible candidates are requested to be present 60 minutes before reporting time on the date of written test cum interview for necessary formalities and verification of documents.**
12. Selected Candidates (s) will be required to produce all original documents(certificates) at the time of Joining for verification purpose.
13. The selected candidate will be required to produce medical certificate at the time of joining.
14. The decision of the Director, ICAR-SBI, Coimbatore will be final and binding on all aspects. The Director shall also reserve the right to terminate the contract of job as mentioned above, even before the completion of the project/contract period for which no appeal thereof shall be made.
15. The Director, ICAR-SBI, Cbe-7 reserves the right to cancel/postpone the scheduled written test cum interview without assigning any reason thereof.
16. In case of any dispute, it will be resolved in jurisdictions of Coimbatore court only.
