It is proposed to fill up four positions of “**Young Professional-II**” on contractual basis under the ICAR-EFC Genome editing project on “Enhancing climate resilience and ensuring food security with genome editing tool” by walk-in-written test-cum-Interview at ICAR-Sugarcane Breeding Institute, Coimbatore-7 (Tamilnadu) on **20.05.2026 at 9.00 AM. as detailed below:**

- Name of Position : Young Professional-II
- No. of Positions : Four
- Duration : From the date of joining to 30.09.2026 and likely to be extended or co-terminus with the above mentioned project whichever is earlier.
- Essential Qualification : **M.Sc /M. Tech in [(Agriculture biotechnology / Plant Breeding and Genetics / Biotechnology / Life Sciences / Basic Sciences/ Plant Pathology / Biochemistry/ Bioinformatics/ Botany).**
- Desirable : Working knowledge of Molecular biology, Plant tissue / cell culture, recombinant DNA technology and basic knowledge of bioinformatics, willing to register for Ph.D programme.
- Emoluments : Rs.42,000/- (Consolidated) per month.
- Age : Minimum age will be 21 years and maximum age 45 years with relaxation as per Govt. of India norms.

**Terms & Conditions**

1. The **written test cum interview** for the above position will be conducted through **in- person** at ICAR –SBI, Coimbatore on **20.05.2026 at 9.00 AM.**
2. The candidates should bring bio-data (in prescribed proforma) entire original certificates from SSLC onwards, one set of photocopies of certificates (self-attested), experience certificate and latest passport size photograph at the time of written test for verification. **Candidates those who fail to submit original certificates for verification will not be allowed for written test.**

3. The candidate should **hold Degree certificate (at least Provisional certificate) in original in r/o. Graduation//Post graduation/Professional courses** (website results/ Awaiting for results candidates will not be allowed/considered).
4. No objection certificate from the employer, in case he / she is employed elsewhere.
5. No TA/DA will be paid to any candidate to attend the Written test.
6. The above position is purely on temporary basis and is co-terminus with the project.
7. There is no provision of re-employment after termination of project. The selected candidates will not have any right for claiming pay scale or absorption against any regular post being vacant on a later date at this Institute.
8. **The selected candidate will be working on whole time basis. He /She will be allowed to register Ph.D. as per ICAR guidelines only with a recognized University by UGC/ICAR-AU system. The student and guide/PI of the scheme must follow the rules and regulations of the Institute as well as the University where the student has registered with.**
9. **To facilitate young professionals in pursuing a Ph.D programme, it has been decided that permission may be granted on a case to case basis to Young professionals recruited under a specified externally funded scheme, provided that the Principal Investigator of the scheme is also the Ph.D Chairperson of the candidate. However, such candidates shall not be permitted to continue the Ph.D programme under any Young Professional position other than the approved scheme.**
10. Concealing of facts or canvassing in any form shall lead to cancellation of candidature or termination.
11. **All eligible candidates are requested to be present 60 minutes before reporting time on the date of written test cum interview for necessary formalities and verification of documents.**
12. Selected Candidates (s) will be required to produce all original documents(certificates) at the time of Joining for verification purpose.
13. The selected candidate will be required to produce medical certificate at the time of joining.
14. The decision of the Director, ICAR-SBI, Coimbatore will be final and binding on all aspects. The Director shall also reserve the right to terminate the contract of job as mentioned above, even before the completion of the project/contract period for which no appeal thereof shall be made.
15. The Director, ICAR-SBI, Cbe-7 reserves the right to cancel/postpone the scheduled written test cum interview without assigning any reason thereof.
16. In case of any dispute, it will be resolved in jurisdictions of Coimbatore court only.
