Eligible candidates are invited for written test- cum- walk in interview will be held on 25th August, 2026 at 10:30 AM at ICAR-Sugarcane Breeding Institute, Regional Centre, Karnal -132001 (Haryana). Terms& Conditions

1. The post Young Professional – II is purely on temporary basis. Initial engagement of Young Professional – II will be upto 31.03.2027 or co-terminus with project or extension of the project and satisfactory performance of the candidate after evaluation by the Director or till any communication received through PPV&FR authority.
2. The selected candidates will not have any right for claiming pay scale or absorption against any regular post being vacant on a later date at this institute.
3. **Concealing of facts or canvassing in any form shall lead to cancellation of candidature or termination.**
4. All eligible candidates are requested to be present 30 minutes before reporting time on the written test cum interview for necessary formalities and verification of documents.
5. Selected candidates will be required to produce all original documents at the time of Joining for verification purposes.
6. The selected candidate will be required to produce a medical certificate at the time of joining.
7. The Director, ICAR- SBI, Coimbatore reserves the right to cancel/postpone the interview without assigning any reason thereof.

8. The selected candidate will be working on a whole-time basis. He/she will be allowed to register Ph.D. as per ICAR guidelines only with a recognized university by UGC/ICAR-AU system. The student and guide/PI of the scheme must follow the rules and regulations of the institute as well as the university where the student has registered with.
9. To facilitate young professional in pursuing a Ph.D. programme, it has been decided that permission may be granted on a case-to-case basis to young professional recruited under a specified externally funded scheme, provided that the Principal Investigator of the scheme is also the Ph.D. chairperson of the candidate. However, such candidate shall not be permitted to continue the Ph.D. programme under any Young Professional position other than the approved scheme.
10. The candidate will get the consolidated emoluments as mentioned against vacancy without any other allowances or liabilities on part of SBI or ICAR or funding agencies.
11. The minimum age for the above post is 21 years and maximum 45 years with relaxation as per rules.
12. The eligible candidate need not send an application in advance but must bring with them original documents (including one set of photocopy), one latest passport size photograph, and experience certificate in original if any at the time of interview.
13. The continuation of Young Professional – II will depend upon the progress reviewed every six months.
14. No TA/DA will be paid to attend the interview.
15. The decision of the Director, ICAR-SBI, Coimbatore (Tamil Nadu) will be final and binding on all aspects. The Director shall also reserve the right to terminate the contract of the job as mentioned above, even before the completion of the project for which no appeal thereof shall be made.
16. In case of any dispute, it will be resolved in jurisdictions of Coimbatore (Tamil Nadu) court only.
