2.	Duration	:	Up to 18.08.2028 or co-terminus with the project whichever is earlier.
3.	Essential Qualifications	:	M.Sc /M.Tech in Plant Pathology/ Microbiology /Biotechnology/any course in Biological Science with 4 or 5 years of Bachelor's degree. or Candidates having post-graduate degree in the above-mentioned subjects with 3 years of Bachelor's degree should have additional NET or equivalent qualifications such as CSIR-UGC NET/ASRB-NET/GATE or selection through any Central Government Departments and their Agencies and Institutions such as DST, DBT, DAE, DOS, DRDO, MHRD, ICAR, ICMR, IIT, IISC, IISER etc.
4.	Desirable Qualifications	:	Experience in Microbiological works, Molecular characterization of bacteria and bioinformatics analysis of bacterial whole genome sequence data.
5.	Remuneration	:	Rs. 37,000/- + 18%HRA per month
6.	Age	:	The upper age limits are 30 Years for Men & 35 Years for Women. The age limits are relaxable for SC, ST & OBC candidates as per Govt. of India norms.

1. The written test cum interview for the above position will be conducted through in- person at ICAR –SBI, Coimbatore on **25.09.2026** at 9.00 AM.
2. The candidates should bring bio-data (in prescribed proforma) entire original certificates from SSLC onwards, one set of photocopies of certificates(self attested), experience certificate and latest passport size photograph at the time of written test for verification. Candidates those who fail to submit original certificates for verification will not be allowed for written test.

3. The candidate should **hold Degree certificate (atleast Provisional certificate) in original in r/o. Graduation//Post graduation/Professional courses**(website results/Awaiting for results candidates will not be allowed/considered).
4. No objection certificate from the employer, incase he / she is employed else where.
5. No TA/DA will be paid to any candidate to attend the Written test.
6. The above position is purely on temporary basis and is co-terminus with the project.
7. There is no provision of re-employment after termination of project. The selected candidates will not have any right for claiming pay scale or absorption against any regular post being vacant on a later date at this Institute.
8. **The selected candidate will be working on whole time basis. He/She will be allowed to register Ph.D. as per ICAR guidelines only with a recognized University by UGC/ICAR-AU system. The student and guide/PI of the scheme must follow the rules and regulations of the Institute as well as the University where the student has registered with.**
9. Concealing of facts or canvassing in any form shall lead to cancellation of candidature or termination.
10. **All eligible candidates are requested to be present 60 minutes before reporting time on the date of written test cum interview for necessary formalities and verification of documents.**
11. Selected Candidate will be required to produce all original documents(certificates) at the time of Joining for verification purpose.
12. The selected candidate will be required to produce medical certificate at the time of joining.
